#### **GUIDED ELECTRIC BIKE TOUR**

Friday, July 24th 2:00pm – 5:30pm

Participants will see Asheville's noteworthy architectural gems, take in stunning scenery from carefully chosen viewpoints, and hear the stories behind Asheville's most significant



historic sites. The state of the art Pedego Boomerang electric bike, which is the lowest step-through electric bike on the market, will help you safely navigate Asheville's hilly terrain through city streets, greenways, and picturesque neighborhoods. It's easy to mount, comfortable to ride, has both pedal assist and throttle power. You can choose how much pedal assist you'd like so you can get a workout or relax and let the motor

do the work for you. The expert local guides, all certified in CPR and First Aid, love sharing insider information while showing you the historic neighborhood around the Grove Park Inn, Pack's Square and Downtown's art deco architecture, eclectic breweries in our South Slope Brewery District, the Basilica of St. Lawrence, Rafael Guastavino's impressive architectural masterpiece featuring the largest unsupported dome in the New World, the grand Victorian and craftsman homes in the Historic Montford Neighborhood and the peaceful Reed Creek and Glenn's Creek Greenways through UNC-Asheville.

**Requirements:** Children must be at least 8 years old, and those ages 8-15 are not allowed to ride their own bike but can ride tandem with their parent. A driver's license is not required, but the legal age to operate electric bikes is 16 years old. The suggested minimum height is 5 feet tall to operate your own e-bike. Shorter participants may accompany another tourgoer as a passenger on a cargo bike. The weight limit for the Pedego Boomerang is 350 lbs and greater for the cargo bikes. While no experience riding an electric bike is necessary, guests must be able to confidently ride a standard bike. Please wear closed-toe shoes, and we also recommend bringing rain gear, sunglasses, sunscreen, and a camera. On the back rack of each bike is a bag the size of a shoe box with a waterproof cover and optional front basket for your belongings.

#### TREETOP ADVENTURE TOUR

Friday, July 24th 12:30pm – 5:30pm

The park features about 50 unique climbing, ziplining, walking, jumping, swinging and rappelling challenges anchored to over 30 trees and towering poles nestled in the wooded park. There are 4 voluntary "trails" to maneuver, one easy, two intermediate, and one advanced trail. Each trail includes 10-15 different challenges that complete a circuit. Guests get to choose the trails they are comfortable with, deciding how much they



would like to be challenged, and they maneuver the trails at their own pace because each guest moves around the park individually instead of in a group. The park is akin to ski slopes



in the trees, a true "jungle gym" for all ages, strengths, and adventure levels. This is made possible by a new technology called "smart belays" which is designed to assure guests are attached to safety systems at all times and they cannot detach themselves from the system until they have completed the aerial trail of their choice and are back on the ground. Some of the elements found on the treetop trails include a cargo net climb, several swinging bridges, and a treetop sliding board into a zipline. There are several themed ziplines at the park, including a

flying kayak, a "giddy-up" horse swing, a hang glider, and an aerial snowboard allowing guests to catch some airtime. There is also a rock-climbing wall that hangs 45 feet in the air, treetop tunnels, a disk golf challenge (called 13th hole), dancing Hula Hoops, a Tarzan traverse, fireman's pole, and the bottomless Burma Bridge.

The easy trail is designed for first-timers, younger children, and more timid adventurers,

has little to no climbing, milder and more stable crossings, is lower to the ground, and has an easy finish back to the ground. The intermediate trails are increased in height (up to 30 feet above the ground), contain several climbing challenges and increased exposure to moving elements, and exits include a rappel and a cargo net escape. At heights up to 50 feet above the ground, the advanced trail is more adventurous, has more personal challenges, has lots of exposure with trees swaying and structures moving as guests traverse the highest and most physically and



mentally challenging activities in the park. Suspended high above the forest floor, the adventure park promotes family or group fun, outdoor adventure, personal growth, physical

fitness and active lifestyles. It is a "must see to believe" attraction, an experience that will create a believer in the fun of treetop adventure.

**Requirements:** The park is designed for participants of average mobility and strength who are in reasonably good health. All guests must be less than 265 pounds, 7 years old and over (some trails require participants to be at least 10, and all children 13 and younger must be accompanied by an adult), and guests must also sign a waiver and release of liability. Closed-toe shoes are required, and we recommend collared shirts and modest, longer shorts or pants dependent upon the seasonal weather. We suggest anyone with medical concerns (such as obesity, high blood pressure, cardiac and coronary artery disease, pulmonary problems, pregnancy, arthritis, tendonitis or other joint and muscular-skeletal problems, fear of heights or other psychological/psychiatric conditions) consult a physician before making a reservation.
